Who Cares? Scotland and Scottish Police Authority Nominated for Scottish Public Sector award

Scottish Police Authority and Who Cares? Scotland recognised as runner up at the Scottish Public Sector Awards.

On Wednesday (6 December 2023) Deputy First Minister, Shona Robison and Deputy Presiding Officer of the Scottish Parliament, Liam McArthur announced the winners of the Holyrood Communications Scottish Public Service Awards (SPSA) in the Garden Lobby of the Scottish Parliament. The Scottish Police Authority ('the Authority') and Who Cares? Scotland nomination was in the Voluntary Sector Partnership Award category, and recognised the joint work undertaken to amplify the voices of Care Experienced people. The Voluntary Sector Partnership Award, supported by the Scottish Council for Voluntary Organisations (SCVO), was ultimately awarded to Edinburgh's community and voluntary sector partnership for Edinburgh's Warm Scots Welcome, a multi-agency response to the displacement of Ukrainian refugees. The Authority and Who Cares? Scotland are proud to have been nominated among such outstanding initiatives.

Promising Practice





In each newsletter we like to share some of the great work Corporate Parents and other organisations across Scotland are doing to help Care Experienced people. In this edition we hear from Falkirk council.

The Falkirk Champs have been working alongside the Falkirk Council services to ensure that all its employees know and understand 'The Promise' that has been made to Scotland's care community and the duties and responsibilities of the people in Corporate Parenting positions. In Falkirk we call it Council Family and Friends not Corporate Parents as the young people didn't feel a connection with this term. The Champs have been delivering training on what it means to be part of the Council Family and Friends and The Promise in its compulsory induction training for all new employees. To date they have trained over 600 people.

The next step was ensuring that the barriers and prejudice that the Care Experienced community can face be recognised and challenged. The Falkirk Champs took the request for care experience to be a protected characteristic to their board meeting to ask for support. The Board comprises of the chief executive of the council Kenneth Lawrie and the leader of the council Cecil Micklejohn among others. While we had the full support of the board including the police, Fire service , NHS it was Cllr Siobhan Paterson who worked along side us to bring the motion to committee.

The young people spoke to the motion and shared the reasons they felt it was important that care experience be recognised this way. It was powerful, emotive, and compelling.

On the 28th June the motion to have care experience to be recognised as being on the list of protected characteristics was passed unanimously. Cllr Paterson shared after that she was proud as 'Not only will we now be able to offer protection, but I hope that we can start to dismantle the barriers and discrimination faced by the Bairns of Falkirk who have been disadvantaged through no fault of their own'

The champs who spoke on the day shared that they 'felt really nervous and out of breath, you can hear it in my voice. I was speaking for so many other voices but I felt powerful, heard and supported' and 'One person even told me how the changes Falkirk Champs are helping to make "heals my inner child" I think that statement alone made me realise how much of a big deal this actually is:)'

During Care Experienced Week 2023 we launched our Lifelong Rights Campaign.

For the past 45 years, Who Cares? Scotland has endeavoured to be at the heart of the Care Experienced community in Scotland.

Because when we ensure everyone in our community has access to the support they need, when they need it, everyone benefits.


However, our learning from our work since we were founded by a group of social workers and Care Experienced people in 1978, tells us that Care Experienced people, from birth to old age, continue to have their rights diluted, infringed, or disregarded altogether.

Our commitment to recording and evidencing what we hear from Care Experienced people reinforces the limited national data available, which shows that Care Experienced people currently do not have the same life outcomes as their non Care Experienced peers.

Our Calls for Change

Change is not just necessary, but very possible, and within reach with a different approach. To achieve equality with their non-Care Experienced peers, we have identified two campaign calls. These are:

- Extra protection for Care Experienced people of all ages to access their rights.
- Independent, relationship-based, lifelong advocacy for every Care Experienced person in Scotland who needs it.
